## 1. Introduction

### 1.1. Introduction to SW-HD3X14K

The KanexPro 3x1 HDMI Switcher is a compact three input to one output switch providing 4K ultra-HD resolutions. It is a simple switcher designed to connect five HDMI sources such as Apple TV, Blu-ray, PS4 or Xbox one to your 4K, HDTV or a projector. Perfect for home theater and pro-sumers looking to connect HDMI based devices to an Ultra-HDTV.





### 1.5. 3X1 Switch Operation controls and functions


- Face Panel: ① Switch button, press this button to switch the input source  
②③④ LED indicator, Indicates the HDMI input port selected corresponding to the LED light




Front Panel: HDMI output port, connect with HDTV, monitor, or projector with HDMI cable




Rear Panel: HDMI input port, connect with Blu-ray Player, PS4, Cable Box, Laptop, and Xbox One with HDMI cable



Right Panel: ① DC 5V input port; ② IR receiver port: connect an IR extension cable and receive the IR Remote signal

### 1.7. Remote Control Functions

① IN1, IN2, IN3, IN4, & IN5: Press any of these buttons to force switch the input port.


The LED light will indicate the corresponding input source.

*\*Note: IN4, IN5 in 3X1 Switch product has not function\**



: Press this button to cycle switch between the input source(s). The LED light will indicate the corresponding input source.

②③④: These color-coated buttons have no function.
